COMMANDER (CONT'D)

JACK

minutes or less.

COMMANDER

Remember, she wrote the book on
interrogation. You're the only one
who can do this.

Jack enters the interrogation room, fumbling through the Saran wrap.

JACK

Spill the beans lady. I've got a
Hapkido tournament at four so I
don't got all damn day.

MARTHA

Shhhh. You're in over your head
Agent Maxwell. I literally wrote
the book on interrogation.

Martha holds up a book, "*Interrogation for Morons*", a *sweded "For Dummies" manual*. Suddenly it's blown away by a gun shot.

JACK

Oops. Looks like I BLEW the ending.

OPENING TITLES: FATAL DECISION. "I'm Jack Maxwell, elite special ops agent, mercenary-for-hire, 2012 Delaware State Fair Hot Dog Eating Champion. If you're a bad guy, word of advice - RUN!"

INT. INTERROGATION ROOM "EMPTY OFFICE" - LATER

The room is empty, being re-painted. A paint bucket and ladder are in the corner.

JACK
(sitting backwards in
chair)
Look. This could go on all day. Why
don't you just make it easy, and
tell me where the bomb is.

MARTHA
No.

Jack firmly yet carefully tips his chair over.

JACK
You wanna play it that way?! Fine!
It's just you and me sister.
Nobody's gonna hear you scream.

Just then a PAINTER enters frame, painting the back wall.

MONTAGE - JACK TRYING DIFFERENT INTERROGATION TACTICS

- Jack does several Karate moves, screaming "Hapkido", in front of a stoic Martha.
 - Jack runs in circles around Martha frantically asking "Where's the bomb?"
 - Jack plays a kazoo loudly in her ear. Martha is unaffected.
- Jack is now seated in front of Martha, miming driving.

JACK
Hey if you don't tell me where that
bomb is, I'm going to turn this car
around!

MARTHA
Dad-tactics. Chapter 8. Page 109.

Jack parks the imaginary car, pulls the break and storms out, slamming the door behind him.

EXT. INTERROGATION ROOM "EMPTY OFFICE" - LATER

Jack, frustrated, mumbles as he flips through the mangled "Interrogation for Morons" book. The Commander approaches.

COMMANDER

Damnit Jack. There's not much time.
I can't just evacuate America!

JACK

I'm trying!

COMMANDER

I was afraid of this. She's too good. She's uninterrogatable.

JACK

If you love her so much why don't marry her? Have a couple kids, and she can do the interrogat -- ?

Jack's eyes glisten with an idea.

INT. INTERROGATION ROOM "EMPTY OFFICE"

Jack enters the room seething.

JACK

JACK (CONT'D)

Ahh! The bomb is under the Pentagon!

Jack punches himself. Martha grows annoyed.

CUT TO:

Later. Chad is putting items back on his desk in the background. Commander has Martha in handcuffs.

JACK

He holds up "Interrogation for Morons", turns to the back where we see a picture of Jack crudely taped on.

JACK (CONT'D)
But *I* published it.

CHAD
Ha.

BODY CAM ON TRIAL - BY EVAN WATKINS

INT. COURTROOM

BODY CAM FOOTAGE - EXT. CAR SIDE ON FREEWAY

Dula walks up to a car window. The window rolls down.

DULA

(O.S.)

License and registration.

The driver hands over his license and registration. Dula clumsily takes it due to the fact that he's holding his pistol. The gun goes off and fires into the street.

DULA (CONT'D)

(O.S.)

Sorry!

INT. COURTROOM

DEFENSE ATTORNEY

Your honor, can we make this
inadmissible?

JUDGE

Nope. Keep playing.

BODY CAM FOOTAGE - EXT. STREET

Dula is directing traffic with a pistol in his hand.

The Defense Attorney skips ahead.

Dula is in the locker room getting pistols duct-taped to both hands by two other officers. A gaggle of other cops stand around drinking beers.

OFFICER

Edward Pistol hands! Woo!

The Defense Attorney skips ahead.

Dula is now on the sidewalk. He strolls up to a little girl looking up at a tree.

GIRL
Mister Officer, my cat is stuck in
the tree.

DULA
(O.S.)
I'll get it.

Dula shoves his shotgun into the tree and starts knocking at
the branches.

DULA (CONT'D)
(O.S.)
Come on. Climb onto the barrel.

INT. COURTROOM - CONTINUOUS

DEFENSE ATTORNEY
Are you totally fucked?

DULA
Oh it was barely loaded!

BODY CAM FOOTAGE - EXT. STREET

Dula now has the cat hanging onto the barrel of the shotgun,
and slowly aims it at the girl so she can receive it.

INT. COURTROOM - CONTINUOUS

JUDGE
Order! Order!

The video cuts to blue as if it's over.

DEFENSE ATTORNEY
Well there you have it your honor.
As you can see there is no --

A loud GUNSHOT is heard.
